- 4) The area between 0 and 300m above the Ostrich Ranch is a no-entry zone. Any flight that enters there will be disqualified.
- 5) Those who damaged third party properties should apologize the third party and compensate if needed. And report back HQ.
- 6) Landing on the trees should be retrieved by the pilot himself.
